STARTING A NEW CHAPTER

De Paul Library's Lonatime Director Penny Lonergan, C'70, Retires

fter a Saint Mary story spanning six decades, Penelope Lonergan, C'70, will retire as Director of De Paul Library on June 30, 2014.

Lonergan came to Saint Mary as a freshman in 1966, noting that "the majority of our faculty and administrators were Sisters of Charity. Very few students had cars; we had stereos and radios but only a few communal TVs in the dorms. There were no phones in dorm rooms; to make an outgoing call we had to use a pay phone."

Many of the Sisters made an immense impact on Lonergan, including her favorite teacher (Sister Barbara Sellers) and past President Sister Mary Janet McGilley.

"Sister Mary Ernestine Whitmore mentored me," Lonergan said. "She was a powerful but gentle person with a penetrating intelligence... Sister Mary Mercita Jackson was the cataloger and my librarian mentor... Though she was never computer-literate herself, she could see computers in the future of libraries, and began the project to convert our holdings from the Dewey Decimal classification system to the Library of Congress system."

Lonergan's career at Saint Mary began while she was still a student. She was among the first team of RA's, and continued as the assistant to the dean of students after graduation.

In 1976 she joined the adjunct faculty when Saint Mary began teaching adult basic education, GED, and college courses in Lansing's state penitentiary. When changes from the Secretary of Corrections "transformed me from an educator to a guasi-correctional officer... I notified my dean of my intention to resign."

Instead, she was asked to become the director of the library.

"When I arrived the library was still using paper in its operations, but I had a mandate to convert it to digital," she said. "We were able to begin that process when the college received a million-plus dollar federal grant for computerizing our campus."

Lonergan's most triumphant contributions to the De Paul library were a lifetime in the making. "Besides transforming the library from paper to digital, we will soon complete the reclassification of all of our Dewey holdings to the Library of Congress classification system—a project that began in 1967," she said.

Alan is a licensed Professional Engineer in 37 states and also a LEED Accredited Professional through the United States Green Building Council. Alan's community involvement includes serving four terms on the St. Elizabeth School Board where he is also a past president. He also served as the athletic director on the St. Elizabeth Athletic Committee for three terms and was a dedicated basketball coach at St. Elizabeth's for 23 years. For the Diocese of Kansas City - St. Joseph School Board he served two terms and was also President of the board. At St. Teresa's, Alan was the Athletic Committee Chair for two terms.

NAMED SCHOLARSHIPS BUILD A LASTING LEGACY

n Feb. 20, 1995, Lorraine Gordon, C'69, established the Emilie J. Gordon Endowed Named Scholarship to honor her mother's legacy. Over the years, Lorraine has created multiple avenues to ensure that her mother's scholarship continues to grow.

For Lorraine's 50th birthday, she asked friends to make a donation to her mother's scholarship in lieu of birthday gifts. This allowed the scholarship to grow beyond the original gift of \$10,000 that is required to set up an endowed named scholarship at Saint Mary. For her 60th birthday, Lorraine did the same thing.

When Lorraine retired from teaching four years ago, she requested donations to her mother's scholarship. This brought another round of subsequent donations — again moving the scholarship financially beyond the original gift.



Lorraine's two children, Rachel and David, who are not Saint Mary alumni, have also generously contributed to their grandmother's scholarship. This brought the scholarship to a different level because donations have now become multigenerational. What a lovely testimony to their mother and grandmother.

Emilie J. Gordon

Since her retirement, Lorraine has continued to tutor and gives clients who are members of her parish the option of contributing to her mother's fund instead of paying her for her consulting services.

Lorraine herself also continues to donate regularly to her mother's scholarship. All this has driven the Emilie J. Gordon Endowed Named Scholarship from \$10,000 to \$24,955 today.

Emilie Gordon, C'71, a native of Metz, France, met and married Lysle Gordon when he was stationed in Europe in World War II. She accompanied her husband to the United States in 1948. After making

sure Lorraine graduated from Saint Mary, Emilie then pursued a bachelor's at Saint Mary and graduated in 1971. She earned her master's in French education from the University of Kansas in 1973. She began working for Saint Mary as an adjunct faculty member in

1972 and continued to be a French Instructor until her sudden death. Just four days after Thanksgiving in 1994, Emilie was tragically killed in a car accident. One of the cars in the accident hit Emilie as she walked along the street. She was 69.

Emilie is honored in perpetuity at Saint Mary, and Lorraine has the satisfaction of knowing that her scholarship will enable future students to receive the same quality education that she and her mother had at Saint Mary College.




WELCOME TO THE REUNION EDITION OF THE ASPIRE!

Tamara graduated with us in '64 and went on to Julliard, and then dropped off of everyone's radar. Her roommates Joan Fitzpatrick, freshman year, and Joyce Zasorin White and Mary Lou Van Sickle Madden, thought she was in New York.

Finally a coworker asked if she could help me. We had tracked Tamara to Ithaca: then we found on the Internet that she had done a poetry reading at a bookstore. I called the bookstore; they knew her, but didn't feel they could give me her information. I gave them mine in the hope that they would pass it on, and I waited a week. Nothina. I composed a letter. enclosed a list of our classmates and the spreadsheet. I added the article from the Aspire on myself, and an article on Sister Mary Vincentia Maronick. I sent it to the bookstore and waited. A week later I got an email, a long one, from Tamara, Yes, she had been in Ithaca and retired for several years. Yes, I could add her to the list. Yeah, one more found!

It turns out that we're spread all over the world.

Maria Teresa Blacut Osborne is in Bolivia. Carolyn Desch is in Combermer, Canada. Wonja Hahn Kors is in Costa Rica. Rei Hasegawa is in Tokyo, Japan, as is Sister Junko Kizawa, who is a Mercedarian sister.

In addition to the work on the computer, I hosted a luncheon for classmates in the Kansas City area last October. Sixteen women came, and laughed and talked for several hours.

In 2012 Margaret Ann Frick and I traveled to Butte, Mont., to see Dianna Porter. While we were there we had lunch with Mary Quastler Chenovick of Helena, Geraldine Miller Baker of Whitehall, and Erin Thompson Sigl from Butte.



This past July I went to Ephraim, Wis. to visit Joan Fitzpatrick and her husband, Walt Fisher, who own the French Country Inn. We had another minireunion, complete with copies of the Taper newspaper from 1960-61 and Joan's green beanie.




